("**AIM Italia**"), as part of the buy-back program, in the period from 7<sup>th</sup> June 2021 to 11<sup>th</sup> June 2021, the purchase of a total of no. 19,425 ordinary shares for a total value of Euro 50,085.00.

The purchases were made with the coordination of BPER Banca S.p.A., an intermediary entrusted with full independence and autonomy for the implementation of the program for the purchase of ordinary treasury shares.
